2. That Govt. of Haryana had ordered on 7.11.2022 for the discontinuation of the D.El.Ed Course from the Private Self Financed Colleges in the State of Haryana.
3. That on 22.2.2024, Punjab & Haryana High Court, Chandigarh in CWP No. 20342 of 2023 has set aside this ban letter.
4. That our state association "Association of NCTE Approved Colleges Trust" requested Most Respected Sh. Nayab Singh Saini, Honorable Chief Minister of Haryana, Govt. of Haryana, Chandigarh & ACS (Elementary Education) Haryana on 15.3.2024 to order for start of the admission for DEEd in the state of Haryana with enclosing a suggested proposal for admission to D.El.Ed. 2 Years Regular Course as special case for the session 2023-25 only in the self finance colleges of Haryana. 7. Eligibility Condition for applying for this course :
  - (a) 10<sup>th</sup>/secondary/matriculation examination from any recognised board with Hindi as one of the subject.

- (b) 12<sup>th</sup>/Senior secondary/10+2 examination from any recognised board with English as one of the subject with minimum 505 marks (47.5% marks for S.C. Candidates)
- (c) No reservation of any category is applicable for admission to self-finance colleges.
- (d) All the admission will be done on the basis of marks obtained in 12<sup>th</sup>/Senior secondary/10+2 examination from any recognised board.
- (e) If there will be any tie between two candidates on the basis marks obtained in 12<sup>th</sup>/Senior secondary/10+2 examination from any recognised board the senior in age will be considered first.

**8.** On the basis of applications received from the students a merit list will prepared by a special admission committee constituted by the principal of this college on 18.3.2024 by 8 p.m. on the basis of marks obtained by the students in the qualifying examination i.e senior secondary examination. And this merit list will be displayed on the website of the college and notice board of the college by 8 p.m. of 31.3.2025.
